## COMPOSTING IS NOW MANDATORY

California state law, SB1383, requires all residents and businesses to compost.



### What is SB1383?

¿Qué es SB1383?

California Senate Bill (SB 1383) "Short-lived Climate Pollutants" is in effect as of 1/1/22. The law requires all residents and businesses to separate organics from their garbage.

La Ley del Senado de California (SB 1383) "Contaminantes Climáticos de Corta Duración" está en efecto a partir del 1/1/22. La ley requiere que todos los residentes y negocios separen los orgánicos de su basura combatir el cambio climático.

### How to Comply

Cómo Cumplir

You need to participate in a compost program for your organic materials. This can be through our free convenient curbside compost service or backyard compost. You can also save money by decreasing your garbage and increasing your compost service. **Route audits will be conducted randomly to ensure that organics are not being placed in the garbage.**

### Why?

¿Por Qué?

This law will reduce methane emissions from landfills and will increase the use of carbon-sinking compost, which greatly helps to combat the climate crisis.

### Odor & Pest Free Libre de Olores y Plagas



It's easy to keep your containers clean and odor-free! Pro tips include lining your food scraps container with a paper bag or newspaper, using a container with a carbon filter, emptying your food scraps container into your green cart regularly, and layering carbon-rich materials such as dried leaves in your green cart. **Compostable plastic bags are not accepted.**

¡Es fácil mantener sus recipientes limpios y sin olores! Los consejos profesionales incluyen forrar el contenedor de restos de comida con bolsas de papel o periódico, usando un contenedor con filtro de carbón; vaciar su contenedor de restos de comida en su carrito verde con regularidad y colocar capas de materiales ricos en carbono, como hojas secas, en su carrito verde. No se aceptan bolsas de plástico compostables.



## Plastics: What You Need to Know

### Plásticos: Lo Que Debes Saber

#### Q: What plastics are recyclable?

A: Rigid plastic containers numbers 1, 2, and 5 (i.e. bottles, tubs, or jugs) can be recycled. Plastics that are not containers (i.e. bags, straws, utensils, or polystyrene foam) should go in the garbage bin. Los recipientes de plástico rígido (es decir, botellas, tarrinas, jarras o vasos) se pueden reciclar. Los plásticos que no sean recipientes (es decir, bolsas, pajitas, utensilios o embalaje y forma de pliestireno) deben ir al basurero.



#### Q: Is polystyrene banned in restaurants?

A: Yes. The polystyrene component of the Polystyrene Foam and Disposable Food Ware Ordinance is currently in effect for Petaluma businesses in an effort to reduce litter and waste sent to the landfill. #### Q: What happens to the plastics in my recycle bin?

A: Recology hauls them to our recycling sorting facility in Santa Rosa, where plastics (along with glass, cardboard, paper, and metals) are sorted out. All of the plastics and most of the other materials are sold to California buyers who recycle them in the state. Recology los transporta a nuestra instalación de clasificación de reciclaje en Santa Rosa, donde se clasifican los plásticos (junto con vidrio, cartón, papel y metales). Todos los plásticos y la mayoría de los demás materiales se venden a compradores de California que los reciclan en el estado.

## Plastic Free Tips

### Intercambios de Plastico

#### Plastic-free swaps and tips:

-  1 Keep reusable bags and produce bags in your car so you never forget them.
-  2 Instead of buying bottled water, use a reusable bottle and/or a filter for your tap.
-  3 Bring a reusable mug to your favorite cafe and avoid the non-recyclable coffee cup.
-  4 When you go to a restaurant or social gathering don't forget your travel utensil set.

#### Other plastic free tips:

Conduct a week-long audit of your plastic trash - use this to figure out swaps • Use the bulk section in the store • Shop at the local farmer's market to cut plastic packaging • Say no to plastic offerings. ## Battery Recycling

### Reciclaje de Baterías

We are now accepting batteries curbside! You can tape the battery terminals and place them in a sealed clear plastic bag **ON TOP** of your recycling cart. **DO NOT** put them inside your cart, as they can cause fires and harm our employees.

¡Ahora estamos aceptando baterías en la acera! Puede pegar con cinta los terminales de la batería y colocarlas en una bolsa de plástico transparente sellada **ENCIMA** de su carrito de reciclaje. **NO** las coloque dentro de su carrito, ya que pueden causar incendios y dañar a nuestros empleados.



## Hazardous Waste

### Residuos Peligrosos

**DO NOT dispose of household hazardous waste in the garbage, recycle, or compost bins.** HHW is extremely dangerous to sanitation workers and must be disposed of properly. 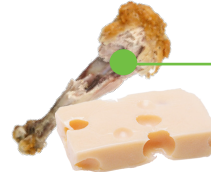

## HOUSEHOLD HAZARDOUS WASTE

Needles can never be placed in any Recology cart, they can harm our workers. They can be taken to the Household Hazardous Waste facility at the Central Landfill.

## COMPOST

Meat and cheese can be placed in your compost cart. The compost facilities process this material at high temperatures killing any dangerous bacteria.

## GARBAGE

Plastic bags and other "flimsy" film plastics cannot be recycled at our facilities and should never be placed in your recycle cart.

## RECYCLE

Ice cream tubs, milk cartons, and aseptic containers (i.e. shelf stable milk and soup cartons) are recyclable as long as they are clean and dry.

## GARBAGE

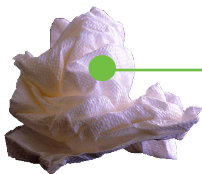
Although these say "compostable", they cannot be placed in residential compost carts because they do not break down quickly enough and degrade the quality of compost.

## GARBAGE

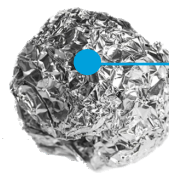
If the surface of a paper to-go container has a reflective quality to the surface or is "shiny" it likely has a plastic coating and cannot be recycled or composted.

## COMPOST

All food-soiled paper (like paper towels or napkins) can be placed in your compost. Make sure the paper product does not have a lining that usually appears as a "shiny" surface.

## RECYCLE

Clean & dry aluminum foil can be balled up and recycled. It must be at least the size of a baseball, so it does not fall through our filters. Items smaller than 3in can't be recycled.

*This material is not recyclable. When collected, it breaks into small pieces that pollute the surrounding area.*



**NO PROPANE TANKS**

*Under pressure these can explode causing serious harm to our workers and damage to our facilities.*



**NO BAGGED RECYCLABLES**  
NO RECICLABLES EN BOLSAS

*Keep your items loose! Bagging recyclables means those items can't be recovered and the bag can gum up our machines.*
