### SENATE BILL 1383: STATE ORGANICS LAW

California's new waste law, SB 1383, is a statewide effort to reduce emissions with one of its goals to reduce organic waste 50% by Jan. 1, 2020, and 75% by Jan. 1, 2025. Organics and compostable materials placed in landfills break down without oxygen. This creates methane, a potent greenhouse gas. Instead, these materials should be disposed in the organics collection where they can be turned into compost which supports our local agriculture and food cycle.

All single family households are automatically provided curbside organics (compost/green cart) service. If you do not have compost service, contact Recology at 650-595-3900 or visit [recology.com](http://recology.com) to set it up.

### POPULAR SHREDDING EVENT IS BACK

Residents and businesses can prevent identity theft by shredding sensitive documents at the City's popular free shredding event. Confidential document destruction includes items such as receipts, checks, pre-approved credit applications, credit card statements, outdated tax returns, pre-printed envelopes and business cards. Participants are limited to three boxes (10" x 12" x 15") per vehicle and materials will be shredded on-site. Documents with paper clips and staples are acceptable. Don't bring e-waste or household hazardous waste.

To practice social distancing, please follow these guidelines:

- Please label "Shred only" on any shredding materials and leave them in the trunk.
- It is recommended to remove all other personal items from the trunk to avoid any accidents.
- Residents will open their trunks before driving up to the vendors, remain in their vehicles with their face masks on, and the vendors will pick up the shredding materials from the trunks.

### SOLID WASTE AND WATER DISCOUNT PROGRAM

The City Council approved a rate assistance program to assist those suffering financial hardship. The program runs through June 30, 2022. Qualified households may receive a 20% monthly discount on solid waste service from Recology San Mateo County and a fixed monthly discount on water service from Menlo Park Municipal Water.

To be eligible for this program, households must meet the following criteria:

- Must be enrolled in the PG&E CARE program, which is another discount program that offers a monthly minimum of 20% on gas and electricity
- Submit most recent PG&E bill to verify CARE enrollment. Address on the PG&E bill must be the same on the solid waste and water bills, but the names may be different
- Submit a most recent Recology and Menlo Park Municipal Water bills to receive applicable discounts
- Re-certify eligibility according to the PG&E CARE program enrollment expiration date.

### UPCOMING HOUSEHOLD HAZARDOUS WASTE (HHW) COLLECTION EVENT

8:30 a.m. – 12:15 p.m.

Location to be announced upon appointment confirmation. Space is limited and appointments are required in advance

Acceptable HHW items include acids/bases, aerosol cans, automotive supplies (car batteries, motor oil, antifreeze, break fluids), cleaning products, fertilizers, pesticides, flammable liquids, fluorescent lights (compact and tubes), paints, inks and photo chemicals. Radioactive, explosive, medical and commercial waste is prohibited.

### ON-CALL BULKY ITEM COLLECTION SERVICE

Twice a year, Recology offers a scheduled pickup service of large and bulky items. Residents may set out:

- Two cubic yards of bagged/boxed solid waste
- One large appliance (such as a washing machine, dryer, refrigerator or freezer)
- One bulky item (such as a mattress, couch or up to four tires without rims)
- Electronic waste (such as a TV, computer or computer monitor)

No liquids, dirt, rock, concrete, asphalt, hazardous waste or items that exceed 5 feet in length or exceeding 200 pounds.
