

## Spring Updates & Tips



California communities are now adapting to new regulations that require organic waste, like kitchen scraps, be composted instead of disposed of in landfills.

A new California law, SB 1383, went into effect on January 1, 2022. It sets new requirements for communities to recycle organic waste. The new law establishes that customers may soon include food-soiled paper such as coffee grounds and filters, pizza boxes, paper food containers, paper towels, paper egg cartons, and other paper materials into the green yardwaste cart.

Food scraps such as fruit, meat, cheese, fish, grains, vegetables, and other food items are also targeted for inclusion into the organic recycling materials.

The yardwaste and organic materials will then be processed into rich compost. This compost will be used to enrich the soil in farms, gardens, and yards in our area.

### Accepted Blue Cart Recyclables

**Paper**-Newspaper, boxes, bags, cardboard (flattened), magazines, catalogs, glossy paper, phone books, softcover books, shredded paper in paper bags, junk mail, envelopes, all colors of office paper.

**Glass**-All beverage and food containers in all colors. Empty container, rinse, and remove lid or cap.

**Plastic**-All #1 through #7 narrow-neck bottles (water, soda, and detergent bottles). All California Redemption Value (CRV) containers. Plastic tubs for margarine, butter, yogurt, etc. Empty all containers and rinse.

**Metal**-Food and beverage cans (aluminum, steel, and tin). Rinse. Clean aluminum pans or foil. Empty aerosol cans. Loose lids from jars.

The following materials are not recyclable. Check website or call for proper disposal instructions.

**Never Mix With Blue Cart Recyclables**  
Paper-No hardcover books or binders; soiled papers, food wrappings, napkins, tissues or towels, waxed paper milk cartons or waxed paper juice cartons.

Glass-No drinking glasses; ceramics; window glass or mirrors; light bulbs or fluorescent tubes.

Plastic-No plastic toys, cups, garden hoses, etc.; plastic bags; packing foam; clam-shell food containers; PVC or other piping; diapers.

Metal-No electronic or computer equipment; hangers; scrap metal; fuel or propane tanks, etc.

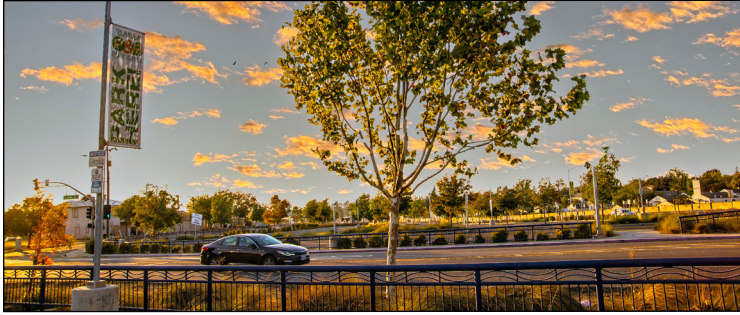

## 2022 Cleanup Day



Bring your extra trash to the Park & Ride on Saturday, April 16, between 10am and 2pm.

Get ready now for the Unincorporated Vallejo Resident Cleanup Day. The event will happen on Saturday, April 16, between 10am and 2pm at

the Park & Ride lot located at the intersection of Lemon Street and Curtola Parkway.

There is no extra charge to residential Vallejo unincorporated area residents to deposit up to 4 cubic yards (a standard pickup truck load) of acceptable items.

The event is only for residential **Recology** customers who live in the unincorporated Vallejo area. A picture ID and a **Recology** or utility bill showing current address are required. **Recology** accounts must be current and not past due. One trip only per household.

### ✓ Acceptable Items

**TRASH BAGS** containing loose trash must be firmly secured in 32-gallon bags and weigh less than 25 lbs.



**TIRES** from cars, pickup trucks, minivans, and sport utility vehicles. Metal wheels attached are accepted

**FURNITURE:** sofas, sofa beds, chairs, futons, dressers, tables, cabinets, bookshelves, desks, and other similar household items.



**APPLIANCES and METAL:** bed frames, scrap metal, pipes, filing cabinets, shelving units, exercise

equipment, bicycles, washing machines, dryers, water heaters, dishwashers, and stoves (NO refrigerators and NO air conditioners accepted).

**CARPETS and PADDING** must be rolled or bundled into 5 foot lengths and must weigh 50 pounds or less per bundle.



**LONG LOOSE ITEMS:** lumber, window blinds, pipes, brooms, and mops tied into bundles no longer than 5 feet in length and weigh 50 pounds or less per bundle.

**ELECTRONICS:** microwaves, TVs, DVD and VCR players, stereo equipment and speakers, computer components such as monitors, printers, central processing units (CPUs), and other electronic items.



**MATTRESSES, FOUNDATIONS and BOX SPRINGS** of all sizes.

### SB 1383 In Effect Now!

Businesses in California must comply with organic recycling regulations established by Senate Bill 1383. The new regulations began on January 1, 2022. The great news is that **Recology** Waste Zero experts are available to help you comply with these regulations. Check the chart on the right for a summary of the new law.

### Senate Bill 1383

- Effective on January 1, 2022.
- Requires all commercial customers to subscribe to organic waste recycling service.
- Customers currently subscribed to yardwaste service must now add organic recycling service.
- Employees must properly sort materials for recycling and organic waste recycling.
- Recycling bins featuring sorting labels will be required in customer areas.
- Select businesses will be required to participate in an Edible Food Recovery Program.
- Food is the largest single source (15.5%) of all waste in California.
- The **Recology** compost facility has been converting food waste and green waste into rich organic compost for years.
