

# Recology Compliance Solutions

**Recology** has the recycling experts and resources commercial customers need to comply with commercial recycling regulations. These laws include:

## **AB 341: Mandatory Commercial Recycling**

Businesses that generate more than four cubic yards of “trash” per week and multifamily residential dwellings of five or more units must subscribe to recycling services. Tenants of these multifamily units and employees of these businesses are required to source separate recyclable materials.

## **AB 1826: Mandatory Commercial Organics**

Businesses and multifamily residential dwellings of five or more units that generate 2 cubic yards or more of solid waste (total of your trash, recyclables, and organics) per week shall arrange for organic waste recycling services. Organic waste includes food scraps, food soiled paper, landscape and pruning waste, and other organic materials.

## **AB 827: Recycling Bins**

Businesses open to the public must provide customers access to the business to provide customers with a commercial solid waste recycling bin or an organic waste recycling bin to collect materials purchased on the premises.

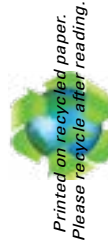
## **SB 1383: Short-Lived Climate Pollutants**

Effective January 1, 2022, SB 1383 requires that commercial and residential customers divert organic materials (including food waste, yard waste, and soiled paper products) from the landfill. The law also requires the state to increase edible food recovery by 20% by 2025.

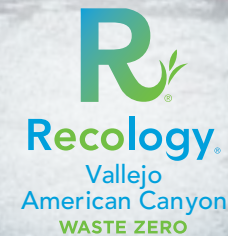

# Commercial Collection and Recycling Services

**Recology Vallejo** and **Recology American Canyon** are proud to provide you with commercial recycling and disposal services.

## Cardboard Recycling Program

Steel bins, used exclusively for cardboard, are provided at no extra charge. Bins are available in 2-, 4- and 6-cubic yard sizes. Each container may be locked with locks provided by **Recology**.

Bins will be emptied as many times as necessary. If needed, additional or larger recycling bins will be delivered. There are no extra charges for these services.

Following is a list of *unacceptable* items for your cardboard bin: *waxed cardboard, cardboard with plastic liners, and garbage or other debris.*

Containers are maintained by **Recology**. For larger projects, we offer debris boxes in various sizes. Please contact our office for more information.

## Recyclables

The blue cart is used for recyclables. The recycling program is easy and convenient, but you should know what materials can be recycled. Placing only the proper materials out for collection helps keep the cost of this service low. Materials that can be recycled are determined by the recycling company that purchases the materials. Check the list to the right for acceptable and *unacceptable* items. There is no additional charge for this service.

## Organics Compost Bin

The compost bin is for organic materials that can be composted such as food scraps, food soiled paper products (like pizza boxes and paper food containers), coffee grounds and filters, meat, bones, fish, dairy waxed cardboard, clean wood, and yard waste. Placing only the proper materials out for collection helps keep the cost of this service low. Materials that can be recycled are determined by their ability to be turned into rich, organic compost. Never put trash, recyclables, or other materials in the compost bin.

## Proper Materials

It is important that only proper materials are set out for collection. Commercial services are easy to use, but it is important to set up your program properly. Employees quickly learn the rules, and the recycling process becomes second nature.

Garbage, hazardous waste, human or animal waste, plastic bags, and other improper materials are not allowed in the recyclables container. Improper materials in your recyclables container may cause them to be left unemptied by your driver. You must then either remove the contaminated materials or have your container emptied and charged additionally as trash. Avoid the extra cost and aggravation.

Lock all exposed cardboard containers with a lock provided by **Recology** at no extra charge. Please keep lids closed on all containers.

## E-waste Recycling

Bring e-waste to the **Recology Vallejo** Recycling Facility at 2021 Broadway, Thursday through Saturday, from 8AM until 4PM. E-waste is accepted at no charge to customers.

Most electronics with an electrical cord are accepted. There is a limit of four computer monitors or four televisions per trip, and customers must unload their items.

## Extra Trash

**Recology** will collect extra garbage or recyclables at your regular collection times. We provide additional collections during the week and deliver debris boxes of 20 yards or more for periodic garbage overloads. **Extra charges apply.**

## Account Status

Notices of overdue commercial accounts are mailed three times a year. It is best to periodically check the account status

of all rental property. Unpaid bills, along with additional penalties, can result in assessments against your property. Customers can avoid these issues by checking their accounts. Please call **Recology** at 707-552-3110 to check your account status.

## Collection Day

Your containers must be accessible by 5AM on the day of your collection. Cars should not block containers, and gates must be unlocked. If you do not receive a pickup, call our office immediately.
